PURPOSE AND BACKGROUND

The purpose of the Plan is to provide an inventory of current Nooksack Valley School District Capital Facilities; identify future school capital facility needs based upon projected student enrollment through the year 2045, identify district goals and future projects and other relevant factors to support the District's growth.

This plan is written in conjunction with the Whatcom County Comprehensive Plan, to assist the County in fulfilling the requirements of the Growth Management Act (GMA). These include the public facility and service provisions of RCW 36.70A.020(12) and the capital facilities plan requirements of RCW 36.70A.070(3). The **GMA's** required components for a School District's Capital Facilities Plan are as follows:

- An inventory of existing capital facilities owned by public entities, showing the locations and **capacities** of the capital facilities;
- A forecast of the **future needs** for each capital facility;
- The proposed locations and capacities of expanded or new capital facilities;
- A Six-Year Plan that will finance such capital facilities within project funding capacities, identifying sources of public money for such purposes;
- A requirement to reassess the land use element if probable funding falls short of meeting existing needs, and
- to ensure that the land use element, capital facilities, financing plan are coordinated and consistent with the Capital Facilities Plan for the County.

EXECUTIVE SUMMARY

The Nooksack Valley School District provides public education services for students in the Central region of Whatcom County, West of the Cascade Mountain range. This Capital Facilities Plan provides an overview of the School District's existing student body, its facilities, future needs and projects, and financing methods.

The School District currently operates five schools: The Primary or Elementary schools are sited in the Nooksack Valley within each of its respective communities; Everson, Nooksack and Sumas. The NV High School is located central to all three communities in unincorporated Whatcom County on Badger Road; the Middle School is sited along SR-544 between Everson and Nooksack, within the Nooksack municipal boundary (Map/P.8).

This Capital Facilities Plan analyzes the school district's capacity to serve projected student populations in the years to come. In summary, with planned capital improvements and the ability to utilize school facilities in a flexible manner, the district will have sufficient classroom space to support projected student growth within the district for the next twenty-year, comprehensive planning period: 2025-2045.

Current funding for facility upgrades and new construction includes two municipal bonds approved by voters in 2014 for \$27.9 million, and in 2019 for \$29.7 million. These bonds will be retired in December 2034 and May 2039 respectively. Future funding to support upgrades to the NV High School is anticipated to be reviewed in 2038-2040.

SCHOOL DISTRICT DESCRIPTION

Nooksack Valley School District No. 506 provides public school services to 1,970 students in PreSchool through 12th grade in Whatcom County. The NVS District operates one high school, one middle school, and three elementary schools. An elected, five-member Board of Directors governs the District with the Board appointing a Superintendent to oversee the District's daily operations and 301 employees. Matt Galley has served as Superintendent since 2021.

The Nooksack Valley School District provides public education services for students in the region and cities of Everson, Nooksack, and Sumas. Both the estimated population of the School District and its student enrollment has steadily increased from 2015 to 2024. See the following tables.

GENERAL FUND EXPENDITURES

For fiscal years 2023 to 24, the District had general fund expenditures of \$34,291,565 (for 8/2023) and \$35,444,384 (8/2024).

2. GREEN INFRASTRUCTURE

The Growth Management Act, RCW 36.70A.030(21) and EPA recommendations for "Green Infrastructure" are intended to recognize how communities are addressing stormwater run-off given its impact on regional water quality. For the NVSD service area, stormwater management affects how each participating community or UGA (Nooksack, Everson and Sumas) will incorporate the impacts of runoff management to their respective Municipal Stormwater Management Programs.

The NVSD has identified the following areas which will affect retention and run-off of storm water:

MIDDLE SCHOOL

Middle School Field: 12.3 Acres including Western Ball Field

- Raised Vegetable and Gardening beds
- 5 drainage fields with native plants
- Various trees and plants throughout the parking lots and around the building
 - Approximately 0.4 Acres of Natural Drainage Beds
 - o Front Lawn: 0.25 Acres
- Grass Fields:
 - Soccer Field: 5 Acres
 - o Baseball Fields (2) and Open Space: 7 Acres
- Natural drainage areas around each building and grounds perimeter

ELEMENTARY SCHOOLS

Everson Elementary School

School Field: 5.5 Acres

10 Raised Gardening beds (480 SF)

Nooksack Elementary School

Rear School Field: 9 Acres includes 1.35 Wooded Acres along Breckenridge Creek.

Front Landscaping at North/Entry: 5.5 Acres.

This portion of the facility contains a natural drainage/retention area (3 Acres)

• 10 Raised Gardening beds (480 SF)

Sumas Elementary School

School Field: 2.7 Acres

Landscaped Area at Drop Off: 1 Acre Parking Lot Drainage Areas: 0.20 Acres

The new parking lot has been designed with natural drainage which drains into 15 Raised Gardening Beds. The design

serves to naturally filter and irrigate the beds.

HIGH SCHOOL

School Field Area: 11 Acres

Outside Sumas, Nooksack and Everson UGAs

- 2 Raised Planter Beds (48 SF)
- Native Plant Garden (500 SF)
- Field space includes Stadium, Practice fields, Baseball Stadium

Ostrum Conservation Site. 38.6 Acres of dedicated conservation area on South Pass Road. Provides public education to the community and includes a portion of Breckenridge Creek.

3. LEVEL OF SERVICE ANALYSIS / CONTINGENCY PLANNING

Level of Service analysis examines the ability of a school district to provide adequate classroom space for students that the District serves. The analysis includes both the current and future conditions.

Student enrollment is projected to increase in the future at a rate of 1.09% per year, based upon the District's student enrollment growth between 2022-24 and the current 2024-25 school year.

The Nooksack Valley School District's student enrollment is projected to decrease from 1,970 in 2024 to 1,630 in 2030 (p.4) (WA Office of Superintendent of Public Instruction) and recover/increase to approximately 2,100 students by 2045. A net increase of 100 students over the 20-year forecast period.

With recent elementary / middle school construction completed, the NVSD has adequate classroom space to serve the students of the District. Projected elementary classroom capacity expansion will be addressed through recently installed portables able to provide instructional space for growth which may exceed the 20-year forecast period. Any emerging enrollment deficit for the high school program will be addressed as current bonds expire and growth shifts in demographics are indicated.

Changing demographics and educational options such as home schooling, the Running Start program at Whatcom Community College & Bellingham Technical College, and on-line classes have affected student



enrolment numbers. Growth continues to increase - however at a lower pace than previous growth periods prior to the Pandemic.

4. IMPROVEMENT PROJECTS AND FINANCING PLAN

The Nooksack Valley School District recently completed renovation and construction of the following:

ELEMENTARY SCHOOLS:

Everson Elementary School (Fall 2020 to Summer 2022)
Addition of 8 classrooms
Nooksack Elementary School (Spring 2020 to Summer 2021)
Addition of 12 classrooms
Sumas Elementary School (Spring 2021 to Fall 2022).
New Facility

MIDDLE SCHOOL:

NV Middle School. New Construction/Relocation. Flood Protection

Bond measures in 2014 and 2019 combined, financed renovations and new construction. These two bond measures will be retired in 2034 and 2039.

CURRENTLY PLANNED PROJECTS AND FUNDING SOURCES (2024 – 2045):

While the district does not have current plans to add additional classroom space, discussion whether to renovate, expand or build a new high school will begin prior to the current bonds full expiration in 2039.

The district will continue to invest in facility improvements as needed.

The district does not have plans to expand beyond its current facility locations.
